GETTING YOUR PRESCRIPTIONS AT THE PHARMACY

Provide your benefits card to your pharmacy and ask them to add your insurance profile — or remove and replace your existing profile if you had prior coverage. The pharmacy will need the BIN, PCN, Member ID, and Rx Group information to process any covered prescriptions.

PRESCRIPTION DISCOUNT PROGRAM

Members will receive discounts up to 80% on most eligible FDA-approved medications. For benefits plans without prescription drug coverage (discount program only), members will be responsible for paying the full remaining balance on all non-healthcare reform medications after the discount is applied.

ONLINE MEMBER PORTAL

ProCare's online member portal allows you to review your pharmacy transactions, find member support information, and more. ADDITIONAL COVERAGE REQUIREMENTS AND LIMITS ON CERTAIN MEDICATIONS*:

FORMULARY:

A formulary is a list of drugs your doctor may prescribe for you including information related to coverage and costs of drugs. This list is subject to change. You can access your drug formulary by contacting your plan administrator, SBMA, at (888) 505-7724 or by referring the formulary specific URL located on the benefit summary for your plan.

QUANTITY LIMITS:

For certain medications, your plan may limit the amount of the medication that will be covered per prescription or for a defined period of time. For example, your plan may provide up to 30 units per 30-day period for a formulary medication.

STEP THERAPY:

In some cases, your plan requires you to first try one medication to treat your medical condition before it will cover another medication for that condition. For example, if Drug A and Drug B both treat your medical condition, your plan may require your physician to prescribe Drug A first. If Drug A does not work for you, your plan may cover Drug B.

*Formulary drug lists are subject to change without notice. Prescription drug coverage may be subject to limitations and exclusions dependent on benefit plans. Some plans may require members to pay for drugs at the point of sale and submit a claim form for reimbursement.
